## EVENT SUMMARY-Outcomes and Deliverables:

**Phase I – OPENING THE DIALOGUE -                      Date:                      April 4, 2009**

**The Goal of Phase I was to:**

Identify hazards - motivate dialogue - survey readiness - promote preparedness – and move towards Community Continuity. Discuss the role of community organizations in disaster preparedness, response and recovery. Discuss what demands will be placed on community groups when disaster strikes; how they will cope and how can they prepare! Determine how community groups can be a conduit to stakeholders and each other to promote preparedness to strengthen community continuity?

Phase I fulfilled its objective by bringing in over 100 community leaders including:

- 3 Chamber of Commerce Presidents from San Pedro, Harbor City and Wilmington
- 8 Presidents and board members from local Neighborhood Councils
- 10 Homeowner Groups
- 5 Neighborhood Watch Organizations
- 14 Executive Directors and Board members of Non-Profits and
- 31 Leaders from various other Community Groups

Phase I provided the community with a specific harbor area Hazard Analysis;  
 Phase I provided useful information through its Keynote Speaker, Dr Lucy Jones and Panel of Experts;  
 Phase I resulted in the development of community mapping program to be implemented in Fall 2009;  
 Phase I recruited **42 new volunteers** who committed to participate in COPE Preparedness;  
 Phase I resulted in expanding Planning Committee participation in preparation for Phase II – *Getting Down to Business* in fall 2009.
